## THIRD-PARTY RIDER DISCLAIMER

1. Our indoor arena and outdoor ménage are available for hire at a minimum hire time of one hour, unless an organised clinic.
2. Each arena can accommodate a maximum of 4 horses at any time.
3. Hirers are asked to arrive in good time and to park considerately by not blocking other vehicles' access.
4. Hirers are asked to keep to their allotted time slot. If the hirer wishes to set up dressage boards or a course of jumps, this must be done within the allotted time unless agreed in writing by management.
5. The hirer shall not use the facilities for any purpose other than the stated "purpose of hire" and shall not sub-hire or allow the facilities to be used for any unlawful purpose or do anything which may endanger the same or any insurance policies in respect thereof.
6. Use of the arena is entirely at the hirer's own risk. The hirer must hold current insurance to a minimum of Third-Party Liability. If an instructor or trainer is using the facility during business, they must hold the relevant professional insurance cover. A copy of this insurance may be requested and retained.
7. Correct footwear and clothing to be worn at all times. All riders must wear protective headgear conforming to the latest BSI standards at all times when mounted, including warming up.
8. For biosecurity measures, at no time must you enter the livery yard, stables or other restricted areas. Please do not have contact with any of the other horses whilst at the premises.
9. The hirer must ensure that all animals engaged in the event or permitted to attend are in good health and are up to date with vaccinations.
10. The hirer will leave the facilities in a clean and tidy state, ensuring all equipment is put away correctly, all droppings removed from the arena, all droppings in the lorry park taken home, and all lights switched off at the end of hire or additional charges will apply.
11. The hirer must read all fire, health and safety notices exhibited and bring their contents to the attention of all attending. Smoking is not permitted anywhere on site.
12. Park your vehicles considerately and be aware of access and other users of the yard and its facilities. Clear up any droppings, hay and/or bedding from the lorry park, as well as any litter, and take these away with you.
13. If there are any breakages, damage and/or concerns about the facilities during your period of hire, we must be notified immediately. Any damage or breakages caused to the property or equipment shall be charged to the hirer at the new replacement value plus any carriage costs.
14. Smile, you're on camera! There is CCTV operational on site.

The proprietor reserves the right to request that riders/trainers/owners or any other person using the facilities do leave in circumstances where in the opinion of the proprietor and/or its management, a person is creating a dangerous situation, riding in a dangerous manner and/or where a person is mistreating a horse or acting irresponsibly. Where a person is asked to leave they must immediately return to their mode of transport and remove the horse and themselves from the premises.

Save for death or personal injury caused by negligence, Tollard Park Equestrian Centre and Equi+Poise Competitions Ltd nor its owners or employees do not accept any liability for any accident, loss, damage, injury or illness to hirers, riders, horses, owners, spectators, property, vehicles and their contents and accessories or any other person or property whatsoever, whether caused by their negligence, breach of contract or in any other way whatsoever during their attendance at the premises in connection with the usage of any of the equestrian facilities. Riding, working with horses and handling horses can be dangerous and horses may be unpredictable. Persons using the facilities do so at their own risk and the proprietor will not be held responsible for any accident, injury or loss.

## **CANCELLATION POLICY**

21. Anyone cancelling their arena hire booking, including book-a-slot, with less than 24 hours notice will not be refunded. Anyone cancelling their clinic booking involving an instructor will only be refunded if the slot can be filled. We reserve the right to cancel any booking should the necessity arise. A full refund or alternative date would be given/offered in this situation.
22. Tollard Park Equestrian Centre and Equi+Poise Competitions Ltd reserve the right to cancel any future bookings if any of the above conditions are not adhered to.
